22 of the Companies(Management and Administration) Rules, 2014, Regulation 44 of the Securities and Exchange and Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in accordance with the requirements prescribed by the Ministry of Corporate Affairs ("MCA") as amended from time to time, read with the General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, and subsequent circulars issued in this regard, the latest being General Circular No. 9/2023 dated September 25, 2023 issued by the Ministry of Corporate Affairs (hereinafter collectively referred to as "MCA Circulars"), Secretarial Standards on General Meeting ("SS-2") issued by the Institute of Companies Secretaries of India and any other applicable laws, rules and regulations. The business transacted through notice are reproduced below:

Special Business:

- 1. To approve raising of funds through Qualified Institutional Placement (QIP)
- 2. Power to give loans or invest funds of the company in excess of the limits specified under section 186 of the Companies Act, 2013.

My responsibilities as a scrutinizer for the voting process through postal ballot by electronic means is restricted to ensure that the voting process was conducted in fair and transparent manner and make the scrutinizer report of the votes cast "in favour" or "against "for the above-mentioned resolutions based on the reports generated from the e-voting systems provided by the Bigshare Services Private Limited, the authorised agency to provide remote e-voting facility.

Based on confirmation received from the Company, I submit my report as under:

1. The Postal Ballot Notice dated 12th December 2023 along with statement setting out material facts under Section 102 of the Act as confirmed by the Company by email to those members who have registered their email address with their Depository Participant(s) ("DPs") or with RTA and whose names appear in the Register of Members/ List of Beneficial Owners as received from Depositories i.e. National Securities Depository Limited ("NSDL") / Central Depository Services (India) Limited ("CDSL") as on Friday, December 8th, 2023 ("Cut-off date"), were entitled to vote through remote evoting in relation to the resolutions specified in the postal ballot Notice. the



advertising was published on 13th December, 2023 pursuant to 22(3) of the Companies (Management and Administration) Rules, 2014 (as amended).

- 2. The dispatch of Postal ballot notice by electronic mode completed on 12th December, 2023.
- 3. In accordance with the aforesaid MCA Circulars, physical copy of the Notice along with Postal Ballot Form and prepaid business reply envelope will not be sent to the members for this Postal Ballot. The communication of the assent or dissent of the members would take place through the process of remote e-voting only.
- 4. The e-voting services were provided by Bigshare Services Private Limited. The remote e-voting commenced on 13th December, 2023 (9:00 AM IST) and ends on 11th January, 2024 (5:00 PM IST) and the Bigshare Services Private Limited e-voting module was disabled thereafter.
- 5. After the closure of the remote e-voting facility, the votes cast through remote e-voting were unblocked forthwith.
- 6. Thereafter, the details containing, inter-alia, list of shareholders who voted as "assent" or "dissent" or "abstain from voting" on the resolution that was put to vote were generated from the e-voting website of Bigshare Services Private Limited i.e. https://ivote.bigshareonline.com.
